Latest news from S:t Christine School in Kabondo

Since the month of January the school has started a new school year. We are happy to look back on a year when the pupils again achieved very good results. All 42 students i eight grade, who left the school, reached the qualification limit for secondary school. The limit is 200 points, and our pupils' results were between 240 and 450 points. An excellent result, which as before is partly due to the fact that the children get two meals in school every day and hence are able to cope with the work. Teachers and other staff also play an important role in the children's wellbeing and their ability to perform so well.

The school's ekonomy

The school is totally dependent on the income the Association manages to get. Finding sponsors and donors in Kenya has shown to be very difficult. The clan culture seems to be one of the obstacles, which is difficult to get around. The Foundation has tried different approaches but not succeded. The golf tournaments, which the Foundation arranged a few years in January, were popular. They generated some revenue, but it turned out to be difficult to establish relations and find sponsors in connection with these competitions.

The budget proposals, which the Association has received from the school, with estimated costs for 2016 excede the revenue we expect to achieve and can guarantee. It will be necessary to implement certain cuts and prioritizing. Unfortunately we are forced to ask the school to be very restrictive with activities and costs, which are not absolutely vital. To be sure that we can operate the school with high quality in the longer run, our estimates show that we must limit the number of admitted pupils unless we can increase our income substantially. The income we have managed to get in the last years corresponds to the costs for 270 students. This shrinks the buffert of money for one semester, which we try to maintain in order always to be able to operate the school one full school year. A discussion regarding a plan for resolving this is ongoing with the Association, the Foundation and representatives for the School.
